



Minutes: On motion by Lion Lee, Lion Dorfler seconding, the minutes of the August board meeting were approved.

Treasurer: Lion Lee made a report on funds currently available. On her motion, Lion Rockwell seconding, the report was placed on file

Request for assistance: Lanore Podolske, on behalf of her son, Jeremy, requested financial assistance of \$1,000 for initial assessment and then a follow up of \$175 treatments for vision therapy and evaluation for dyslexia because of difficulty reading. Since it was unclear the problems are vision-related, and since they are insured by Blue Cross/Blue Shield, the Board unanimously voted to deny the request.

Old Business:

-Lion Rockwell made a preliminary Steer Roast report. Attendance was down 50 diners from 2010. Since all receipts have not been received, he and Lion Lee will put together a final report for the November meeting. 35 people were screened for hearing loss. Ten were found to have some hearing loss.

-Lion Rockwell reported that a slate had been finalized and would be presented at the General Meeting
