

After dinner, guest Joyce Campbell spoke about the origin and operations of the Oasis, otherwise known as the Grayslake Youth Center. In a building some remember as first the police department, then the park district, the Oasis is a place for young people to congregate. Ms. Campbell initiated the creation of the Oasis. First questions were start up funds (the Grayslake Lions Club contributed) and whether it would be sustainable. It has

There are live bands on weekends and they offer foosball, air hockey, pool and a pin ball machine. There is a small stage for productions and showing of age-appropriate DVD movies. The building is available on Sundays for private parties (\$295, 40 people, 4 hours). It is open 3-9 PM, Monday to Thursday and Fridays and Saturdays. One adult is always present. They have a staff of 6 and are organized as a 501(c)3 charitable organization. On April 21, they will celebrate their 5<sup>th</sup> anniversary and the public is invited. Lion President Dietz (M) thanked Ms. Campbell for an interesting presentation.
